

🕼 Combustion 🔆 Refrigerant (HFCs) 🗲 Electricity






California's Building Decarbonization Goals

- Support carbon neutrality by 2045
- 6 million heat pumps deployed by 2030
- Climate-friendly and climate-ready homes:
 - 3 million by 2030
 - 7 million by 2035
- Load-shift goal of 7,000 MW by 2030



Residential Units 13.7 million Annual Electricity Consumption 93,522 GWh Annual Gas Consumption 4,562 MM therm



Commercial Space 7,392 million sq. ft. Annual Electricity Consumption 105,174 GWh Annual Gas Consumption 2,130 MM therm

Building Decarbonization Incentive Programs (~ \$1.7 B)

Equitable Building Decarbonization (\$922M)

- Statewide Direct Install (\$643.7M)
- Tribal Direct Install (\$30M)
- Existing Programs (\$30M)
- Statewide Incentive Program (\$80M)
- Program Admin. (\$138.8M)

BUILD (\$80M) & CalEHP (\$75M)

- Building Initiative for Lower-Emissions
 Development
 (BUILD)
- California Electric Homes Program (CalEHP)
- Focus on new construction for low-income & market rate homes

Demand Side Grid Support Program (DSGS) (\$314M)

- Incentives to electric customers that provide load reduction & backup generation
- Supports the state's electrical grid during extreme events, reducing the risk of rotating power outages

Inflation Reduction Act Programs (\$592M)

- HOMES | Efficiency (\$282M)
- HEEHRA | Electrification (\$280M)
- Contractor Training (\$10M)
- Tax Credits & Technical Assistance (\$10M) (state)

CEC: Key Standards Supporting Decarbonization

- Building Energy Efficiency Standards (Title 24, Part 6)
 - CEC authority is to reduce energy consumption
 - 2022 Standards Heat pump (HP) baselines for new construction
 - 2025 Standards (*in process*) Expand requirements for new construction and add requirements for alterations
- CALGreen (Title 24, Part 11): Enables local governments to "stretch"
- Appliance Efficiency Regulations (Title 20)
- Load Management Standards (LMS)
- Flexible Demand Appliance Standards (FDAS)



R&D – Electric Program Investment Charge (EPIC)

Continued energy innovation will play a key role in ensuring California benefits from clean, affordable, safe, and reliable energy – propelling the state as the world's fourth largest economy while advancing leading-edge climate change solutions.
